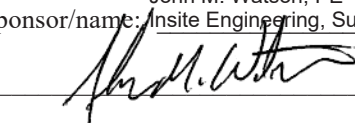

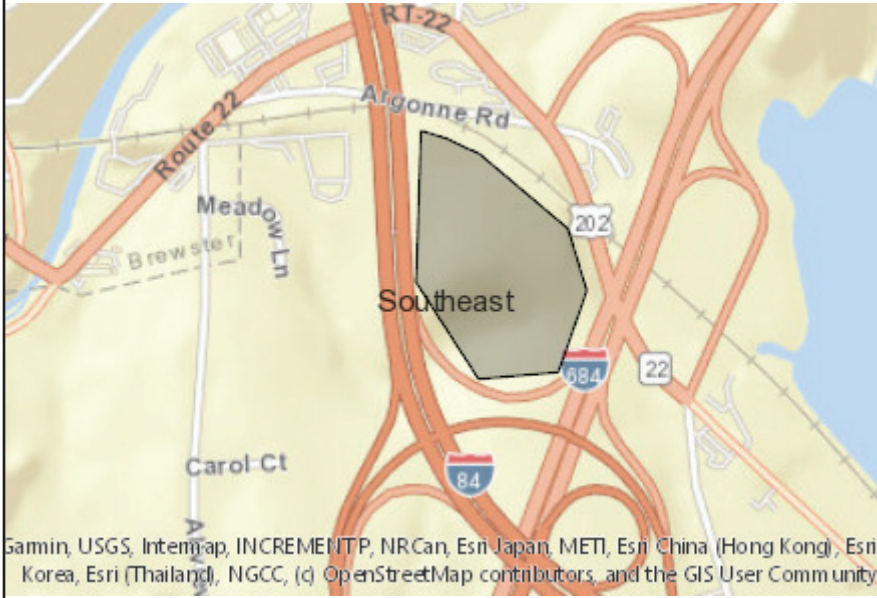

Brief Description of Proposed Action: The applicant, 1051 Route 22, LLC wishes to develop the property located at 1051 and 1055 NYS Route 22/202/6 in Southeast. The property resides in SR-6 zoning district and is approximately 17.0 AC±. The intended use onsite is office/general business and warehouse space with accessory parking areas and outside storage. Proposed development includes the construction of two commercial buildings with associated parking areas, stormwater management, gravel outside storage, lighting, and landscaping. Also proposed are tiered parking lots with solar canopies.  Although the property has almost 70% road frontage, access is only available along a 300-foot section of NYS Route 22. The property borders NYS Route 22/202 and US 6, US Interstates I-684 and I-84, and the Putnam County Rail Trail.  There are town regulated wetlands and a watercourse onsite with associated controlled areas. Portions of the parking areas and access drives are located within the controlled areas. Mitigation plantings are proposed to offset this disturbance.
