1) La Frontera – Sign Review

This application is for a hanging post sign. The applicant has modified this sign per recommendation of the building department.

2) Real Estate Solutions – Sign Review

Tom Frasca recused himself from discussion and decision on this application.

This application was previously reviewed and denied by the ARB on their meeting of October 17, 2006. At that time the representative was not present.

The application is for a 12.271 square foot sign made of ¼ inch PVC. The sign is proposed to have red and blue lettering. The ARB found the sign inappropriate, given the design and coloring of the words. The ARB felt the sign looked too

much like an advertisement, rather than a store sign.
The word "free" in large bold letters was found to be inappropriate for a sign.
The ARB would like to see the name of the business on the sign.

The applicant agreed to return to the ARB with a revised sign application

3) Dykeman Corporate Park – Review of Commercial Structure Representative: Terri Hahn, Harold Lepler, Alfred Demarco

This application is for two warehouse buildings proposed to be 25,000 sq. ft and 20,000 sq. ft. Building 1 is a speculative building intended to be used by small trades companies such as plumbing or other General Business Contractors. Building 2 is proposed to move Lisi's Towing from Route 6 to this location.

Both buildings are proposed to masonry block with color and texture highlights. Both buildings will be both smooth block and split face block in a light grey and darker grey color, as indicated on drawings A-1 and A-2. Both buildings will have red trim around the top of the buildings.

The building elevations will be refined once the tenants are identified. At this point, the elevations will be resubmitted to the ARB.

The ARB found the proposed elevations, as presented on the following drawings prepared by LADA, P.C. and/or Bibbo Associates, LLP:
