1) Brewster Plaza – Review of Structure

The application includes the incorporation of new tenant spaces within the existing building, an upgrade of the exterior and segmentation of existing tenant spaces.

-Natural stone

-Synthetic stucco material

2) Pegasus Therapeutic Riding– Review of Structure

This application is for an indoor riding ring and horse barn with the following characteristics:

-Corrugated vertical steel siding in beige

-Corrugated steel roofing in "ivy" by Everlast Roofing, Inc.

-Clear (untinted) translucent corrugated fiberglass panels to permit filtered natural light into indoor riding ring

At the meeting of February 20, 2007, the ARB requested the following changes:

- Applicant should present sight line drawings from Route 121 to demonstrate views from the street.
- Applicant should address proposed lighting and signage in future submissions
- Applicant should potentially reduce the gable on the front (street-facing) side of the proposed structure

At this meeting, the ARB provided the following for consideration:

- Sight lines indicating that only a small portion of the structure will be visible from Route 121
- Modifications were made to the front gable
- Sample materials, including siding and roofing, were presented.
- The applicant indicated that site lighting would be cut-off fixtures that would provide minimal fc amounts. Further review of lighting will be completed by the Planning Board.
- The applicant will return to the ARB for review of the proposed sign.

Given the presentation of the requested material and plan modifications, the ARB voted to positively recommend this application to the Town board.
