1) Arborscape – Review of Structure

Representative: Stefan Karlson, Arborscape

This application includes two drawing sheets dated February 1, 2007 ([5] Elevations and [6] Site Details and Notes) for a barn with the following characteristics:

Siding: Pro panel II metal sheeting

Roof: Pro panel II metal sheeting; color- taupe

Foundation: stone veneer (stone to match existing on site)

Arch Details: wood cupola with timberline architectural shingles and weathervane

The applicant stated that the barn would be set back from the road approximately 150 feet and would be screened with vegetation.

Based on ARB recommendations at its meeting of June 17, 2007, the applicant made the following changes:

- Increased the mass of the cupola.
- Provided photographs of the existing house and surrounding views in order to establish the context.

The ARB had the following additional recommendations and requested that the applicant return at its next meeting:

- Repeat the divided light detail on the cupola.
- Increase the roof pitch.
- Details should reflect the details of the existing house, including the color.

The applicant returned with the following revisions:

- Repeated divided light detail on the cupola.
- The pitch of the roof can not be modified due to structural requirements. This was found acceptable to the Board.
- The design now reflects the details of the existing house. The house and shingle color will be white to match existing house.

The ARB voted to positively recommend the application to the Town Board.
