BUDGET TRANSFERS

WHEREAS, the Town of Southeast, working with the Trust for Public Land, has acquired two parcels of land from the United Jewish Appeal (“UJA”) consisting of approximately 166 acres and located in the vicinity of Pugsley and Zimmer Road, know generally as Tax Map No. 45., Block 1, Lots 10 and 11 (the “Premises”); and

WHEREAS, at the time of acquisition, the Town Board of the Town of Southeast committed to convey a portion of the Premises consisting of approximately ten (10) acres to Putnam County and/or the Putnam County Humane Society (“PCHS”), or its designee, to be used and improved as the new home for the PCHS animal shelter; and

WHEREAS, it is the sense of this Town Board that the Town should reaffirm its commitment and, in furtherance of this goal, take certain actions necessary and proper toward achieving this goal.

NOW, THEREFORE, BE IT

RESOLVED, that the Town Board hereby confirms its commitment to convey a portion of the Premises consisting of approximately ten (10) acres located in the vicinity of that portion of Zimmer Road the terminates at the Interstate Route 84 taking line (the “Acquisition Parcel”); that such conveyance be at a fair market value for the parcel as vacant land as determined by an independent appraiser or appraisers retained for the purpose of determining value; that a competent engineer or surveyor be retained to determine the exact metes and bounds of the Acquisition Parcel and that a proposed subdivision plat be prepared for review by the Town Planning Board; that the Town Attorney be authorized to draw and prepare a contract of sale or other agreement to be entered into to memorialize the understandings subject to all applicable laws and restrictions; and that the preliminary costs associated with the identification of the Acquisition Parcel and the subdivision of the Acquisition Parcel from other lands of the Town of Southeast be a cost borne by the ultimate purchaser.

WHEREAS, the State Police have sought the financial assistance of the Town to acquire new and advanced laser speed detection and enforcement devices for use by State Police officers.

RESOLVED, that the Town board hereby finds that the acquisition of speed detection and speed enforcement devices will improve the health, safety and welfare of the residents of the Town of Southeast; and be it further

RESOLUTION # /2008 SUPPORT OF STATE LEGISLATION TO EXPAND RETURNABLE CONTAINER ACT

Introduced By: Councilman Johnson

Seconded By: Councilman Honeck

WHEREAS, New York State's Returnable Container Act (the "Bottle Bill") has been in effect since July 1983; and

WHEREAS, this law requires a minimum five cent refundable deposit on carbonated soft drinks and other beverages, thereby creating an economic incentive for the collection, return and recycling of these beverage containers; and

WHEREAS, it is estimated that the Bottle Bill has resulted in a seventy-five percent average return rate over the past twenty-five years; and

WHEREAS, this law has reduced litter resulting in safer, more attractive streets, parks, playgrounds, beaches and roadsides and has prevented injuries and property damage which could have resulted from broken glass; and

WHEREAS, non-carbonated beverages such as bottle water, tea, juice and sports drinks now make up more than twenty percent of the beverage market in New York State; and

WHEREAS, the current law does not provide for the disposition of unclaimed deposits; and

WHEREAS, Senate Bill S5850A and Assembly Bill A8044A would expand the Bottle Bill to include bottled water, tea, juice, and sports drinks and would require that the unredeemed deposits be submitted to the State Environmental Protection Fund to support municipal recycling projects and waste prevention programs and other critical environmental needs, thereby creating a valuable source of new revenue to help fund these important causes.

NOW, THEREFORE, BE IT

RESOLVED, that the Town Board of the Town of Southeast does/does not urge state lawmakers to enact S5850A/A8044A, which would expand and update the Bottle Bill to increase recycling, curb litter, reduce costs for municipalities, and provide a steady stream of funding for recycling, waste prevention, and other environmental programs; and be it further

RESOLVED, that the Clerk of the Town of Southeast is hereby directed to forward copies of this resolution to Governor David Patterson, Senate Majority Leader Joseph L. Bruno, Assembly Speaker Sheldon Silver, State Senator Vincent Leibell and Assemblyman Greg Ball.
