WHEREAS, the Town Board (the “Town Board”) of the Town of Southeast, New York (the “Town”), has duly caused to be prepared an estimate of the cost of the increase and improvement of the facilities of the Town’s Starr Ridge Water District (the”District”); and

WHEREAS, such increase and improvement of facilities consists of the replacement of a 25,000 gallon buried potable water storage tank, the replacement of a 5,000 gallon buried hydro-pneumatic tank, including without limitation, the replacement of selected associated controls and instrumentation and the reconstruction of the interior facility, including without limitation, the replacement of piping, fittings, valves, unit heater and air compressor for the district (the “Project”); and

WHEREAS, it is proposed to finance the Project by the issuance of \$243,000 serial bonds of the Town, payable through assessments levied and collected upon the taxable properties within the District; and

WHEREAS, the Town Board hereby determines that the Project is a “Type II Action,” does not have a significant effect on the environment and does not require an environmental impact statement or any other determination under the State Environmental Quality Review Act, and

WHEREAS, the Town Board on April 14, 2005, duly adopted a Resolution and Order Calling Public Hearing calling a public hearing to consider the increase and

improvement of facilities of the District consisting of the replacement of a 25,000 gallon buried potable water storage tank, the replacement of a 5,000 gallon buried hydro-pneumatic tank, including without limitation, the replacement of selected associated controls and instrumentation and the reconstruction of the interior facility, including without limitation, the replacement of piping, fittings, valves, unit heater and air compressor for the District at the total estimated maximum cost of \$243,000, and to hear all persons interested in the subject matter thereof; and

WHEREAS, pursuant to such Order and Resolution a Notice of Public Hearing was duly published and posted pursuant to the provisions of Article 12 of the Town Law: and

WHEREAS, such public hearing was duly held by the Town Board on May 12, 2005, at 7:31 o'clock A.M. (Prevailing Time) at the Civic Center, 67 Main Street, Brewster, New York, in said Town, and discussion on the matter having been had and all persons desiring to be heard having been heard, including those in favor of and those in opposition to said increase and improvements of facilities;

NOW, THEREFORE, IT IS

DETERMINED, that it is in the public interest to increase and improve the facilities of the District as hereinabove described and referred to at the total estimated maximum cost of \$243,000, and it is hereby

ORDERED, that the facilities of the District shall be increased and improved as hereinabove described at a cost not to exceed \$243,000; and it is hereby

FURTHER ORDERED, that the cost and expense of said increase and improvement of facilities shall be assessed, levied and collected from the several lots and parcels of land within the Starr Ridge Water District in the same manner and at the same time as other Town charges; and it is hereby further ordered that the Town Clerk record a certified copy of this Resolution and Public Interest Order After Public Hearing in the Office of the Clerk of Putnam County within ten (10) days after adoption thereof.

WHEREAS, pursuant to such Order and Resolution a Notice of Public Hearing was duly published and posted pursuant to the provisions of Article 12 of the Town Law; and

FURTHER ORDERED, that the cost and expense of said increase and improvement of facilities shall be assessed, levied and collected from the several lots and parcels of land within the Fox Hill Water District in the same manner and at the same time as other Town charges; and it is hereby Further Ordered that the Town Clerk record a certified copy of this Resolution and Public Interest Order After Public Hearing in the office of the Clerk of Putnam County within ten (10) days after adoption thereof.

John Cesar “Rooster for Brewster” program

A question was asked about Deans Corners and why two approvals were still not received. Another concern is why it was left off the list and also would it need another public hearing. The Supervisor said it was left off the list inadvertently and it would be on a further worksession.

Don Cuomo submitted a petition regarding the paving of Maple Road and a letter for the record, which he read. A resident would like the cost of paving the entire road. Another resident said the speed limit of 20 mph is posted and they should not drive faster.

When questioned about drainage districts the Supervisor said the report was almost finished. He also responded that Malcolm Pirnie is being hired primarily for Peaceable Hill District. Regarding Deans Corners a transportation Corp and a Homeowners Association will both be needed.

The Supervisor said that the town-wide newsletter was mailed to every residence and every dwelling that had 3 or less families.

The Mayor said that paving Maple Road would make it a speedway.
