CALL FOR THE ORDER OF THE DAY – Councilwoman Hudak

Supervisor Rights made a motion to open the meeting. Councilman Gross seconded. All in favor.

PUBLIC HEARING – BREWSTER HONDA REZONING – CONTINUATION

This is a continuation of a hearing regarding Brewster Honda from January, 2010. The mailings were submitted to the Town Clerk by Mr. Richard O'Rourke. A full presentation was made at the first public hearing on January 21, 2010. There has been a change since the last meeting as requested. A conservation easement is in place to limit the use and disturbance of the property; more than half the land is conserved. There was a letter from Putnam County Planning on 2/9/10 and they are in agreement with the Southeast Planning Board. A letter from Mr. O'Rourke was emailed and hand-delivered which address some of the concerns from the last meeting on January 21. The property has been commercial for at least 30 years and there were also several commercial uses permitted as of right. He, O'Rourke spoke of the concerns that he addressed in the letter. There are exhibits to show that the property has never been abandoned. The case law is the Master Plan. A copy of Mr. O'Rourke's letter is attached at the end of the minutes. Councilman Gross asked about the fencing. Tim Allen from Bibbo Associates said there will be a full tree barrier and will try to go as close to the payment area as possible. The conservation line is the septic area. This is an R-60 zone and half of the property is never to be developed. Until recently there was a daycare center, but until 2008 the site was operated by Dill's Best as a distribution center with trucks being used. A resident said that they moved in 5 years ago and never saw one.

Mr. Ito said that the meeting was not properly noticed to the residents and that there was no sign on the property as required. He said that the town has to be satisfied that these requirements have been met. He said that the sign was posted 16 months after the application was filed. Any zoning amendment has to be in accordance with the comprehensive plan. Mr. O'Rourke said that the sign was up in advance of the first zoning public hearing as required. The water source is within 300 Feet and 100 feet from the intersection. Mr. Ito said that they should look at the code and the comprehensive plan in its entirety and to make sure each piece fits together. Mr. Ito said that this operation can go anywhere except for the special zone that the town created. Mr. O'Rourke said the referral went to the Putnam County Planning Department and that they are in agreement with the Southeast Planning Department and report. Everything has to be done as required by law.

Richard. Reinhardt asked if a contract to buy had a clause in that it was subject to these approvals. The answer was no. Keith Green spoke for the Allview Avenue/Meadow Lane Coalition which has 50 homes within the area. He feels that Brewster Honda should not be trusted. They also feel it is a Motor Vehicle Service Station and that the Planning Board did not take a hard look at the application. He then went over their application. Ann Fanizzi said she thinks that this is a bad project and everyone including applicant will get confessed by the

process. She also said that she feels that their property valuations will be effected. Supervisor Rights made a motion to close the meeting and Councilman Cullen seconded; all in favor.

PUBLIC HEARING – NORTH SALEM AMBULANCE SPECIAL DISTRICT – CONTINUATION OF PUBLIC HEARING

Kurt Guldan appeared for the Ambulance Corp –no correspondence was received regarding this matter. He was asked to furnish copies of contracts that he has with all other districts. Town Counsel advised that once they find the assessment per tax lot then there must be another public hearing and a notification to each household. Supervisor Rights made a motion to close and Councilwoman Hudak seconded. All in favor.

PUBLIC HEARING - VALLEJO KENNEL SPECIAL PERMIT

Supervisor Rights made a motion to open the public hearing and Councilman Cullen seconded – all in favor. Town Clerk Mazzei read the legal notice. Mr. and Mrs. Vallejo appeared accompanied by their attorney Mr. Lusardi – they did not do the proper notifications but said that Supervisor Rights and his secretary had told them that they did not have to do anything else. Councilman Stephens explained that they must follow the requirements and quoted the section of law that they must follow. They will return for the public hearing on March 18, 2010. The motion to open and second was withdrawn.

PUBLIC HEARING – CANVAS/FABRIC STRUCTURES – REPEAL OR AMEND LOCAL LAW

Supervisor Rights made a motion to open the public hearing and Councilman Yee seconded. All in favor. Town Clerk Mazzei read the legal notice. This hearing would seek to appeal or amend Local Law No. 2 of 2009 which amended Chapter 138, Section 138-13 of the Southeast Zoning Code to prohibit the use of fabric covered storing structures. Bradley Swartz appeared and explained that in past meetings that it was suggested that existing structures be permitted but also asked about replacing the current fabric-covered structure. Certain aesthetics were addressed and the law needs to be improved. Paul Guidotti said that enough is enough and he feels that this law is stepping on people’s property rights. He thought this law was a little too broad and controlling. Supervisor Rights made a motion to close the hearing and Councilwoman Hudak seconded; all in favor.

PUBLIC HEARING – DOG – LOCAL LAW INCONSISTENCIES

Supervisor Rights made a motion to open the public hearing and Councilwoman Hudak seconded. All in favor. Town Clerk Mazzei read the legal notice. This proposed law would amend chapter 60 entitled “dogs” and Chapter 138, Section 138-17 “General Use Requirements” to correct inconsistencies and coordinate the permissible number of domestic animals permitted in residential districts as of right or by special permit. Town Counsel provided copies of the laws in question, and feels that this could be corrected quite easily by redacting some items. This would make the code consistent with the law that was earlier adopted. Supervisor Rights made a motion to close the meeting and seconded by Mr. Yee.

RESOLUTION #05 /2010 LANDFILL CLOSURE

INTRODUCED BY: Councilwoman Hudak

SECONDED BY: Supervisor Rights

WHEREAS, the Town of Southeast is under a New York State Department of Environmental Conservation consent order to close and cap its municipal landfill located on Lower Mine Road; and

WHEREAS, significant progress toward final closure has been made in recent years including the relocation of waste mass from Metro-North Railroad property to the Town Landfill; and

WHEREAS, the Town is now in a position to orchestrate the final contour grading, capping and other related matters; and

WHEREAS, the Town has been presented with several opportunities that will facilitate the landfill closure and present some potential cost savings and other economic benefits to the Town;

WHEREAS, it is the intention of the Town Board to direct and authorize Sterling Environmental, the Town’s engineering consultant, working in concert with the Town Board and Town Attorney to undertake the appropriate steps and actions to move the project expeditiously to completion.

NOW, THEREFORE, BE IT

RESOLVED, that Sterling Environmental Engineering (“Sterling”) is hereby authorized and directed to proceed with the preparation of Plans, Specifications and Contract Documents for the Landfill Final Cover Installation, including, but not necessarily limited to, the preparation of the Advertisement for Bids, Notice to Bidders, Bidding Specifications and the Construction Agreement.

The Construction Agreement will provide for bids to be received as follows:

Contract 1A: Furnish and Install Grading Material

Contract 1B: Installation of Final Cover System

Alternates

In addition, Sterling is authorized and directed to prepare a Bid Form, conduct Pre-bid Meeting(s) at the Landfill, issue any and all clarifications and Bid Addenda as it may deem proper. Sterling shall evaluate the Bids once received, prepare a Bid Tabulation for the review of the Town Board, review qualifications of Bidders and make recommendations to the Town Board regarding the low, qualified Bidder; and be it further

RESOLVED, that once the Bid Specifications and Contract Documents are prepared in a manner satisfactory to the Town Board and Town Attorney, the Town Clerk is authorized to cause an advertisement to Bidders in the appropriate newspapers and periodicals as recommended by Sterling; and be it further

RESOLVED, that the Town Clerk is hereby designated as the person to receive the sealed bids regarding the Landfill Closure Project; and be it further

RESOLVED, that Sterling is authorized to assist the Town in its on-going negotiations with Putnam County regarding the potential relocation and consolidation of a waste mass from a county-owned landfill in and to the Town’s Landfill and, in anticipation of a mutually beneficial agreement between the County and the Town, Sterling shall provide flexibility in the bidding and contract documents to accommodate the possibility of the County waste mass being introduced into the Southeast Landfill; and be it further

RESOLVED, that in the event mutually agreeable terms and conditions can be reached, the Town Attorney is hereby authorized to negotiate and prepare an inter-municipal agreement with the County of Putnam for this purpose; and be it further

RESOLVED, that the Town shall provide interim project financing for the ensuing phases of the Closure Project through the issuance of necessary bonds, bond anticipation notes or other financing instruments customary and proper in relation to a capital project of this nature and that the Town’s Bond Counsel is hereby authorized and directed to commence any and all proceedings as may be necessary to fulfill the requirements of the Local Finance Law in relation thereto.

COMPREHENSIVE PLAN AMENDMENT
