Protecting and Improving Lake Tonetta – A Shared Responsibility

Residents of the Town of Southeast are fortunate in having the opportunity to enjoy one of our most precious resources, Lake Tonetta. Lake Tonetta is not only an environmental asset, but more importantly, is a source of beauty and enjoyment where we can experience the pleasures of swimming, boating, fishing or just thoughtful observation.

The Town Beach and Tonetta Heights Beach on Lake Tonetta are tested regularly through the year by the Putnam County Board of Health, and is considered safe for recreational purposes.

However Lake Tonetta has, in recent years, suffered the effects of increased development and the transition of summer homes into year-round residences. The increase of nutrients flowing into the lake through failing septics, washing machines, fertilizers, roadway drainage and other sources, has

caused some of the recent problems, including aquatic plant overgrowth and algae blooms.

Even if you don't have lakefront property, you are probably in the Lake Tonetta watershed. This extends up Brewster Hill, including Tonetta Heights, much of Tonetta Lake Park and thanks to the storm drains, as far away as Route 312. What can be done? In this newsletter we will address ways that the homeowner, residents and visitors can help improve the quality of the lake.

Pick Up After Your Pet

Keep your yard free of waste, don't leave pet waste lying around in the watershed.

Waterfowl – Please do not Feed

The increasing population of Canadian Geese, Sea Gulls and other waterfowl is creating a problem for Lake Tonetta. These birds create a large amount of waste which add unwanted nutrients and bacteria to the lake and they

stir up sediment from the Lake bottom.

Feeding these birds encourages a larger population than the lake would normally sustain and causes them to stay longer before migrating south.



Fertilizers and Water Quality



Aquatic plants, like their counterparts on land, require nutrients to grow and reproduce. Phosphorous is the nutrient responsible for much of the overabundant growth of aquatic plants and algae. Phosphorous is a nutrient all plants and healthy lawns need for root growth; however, most soils already have enough phosphorous and adding more will be a WASTE OF MONEY because it won't help your lawn or garden.

When it rains, runoff from lawns and gardens enters the lake directly or through storm wa-

ter drains that eventually lead into the lake. To limit the amount of phosphorous entering Lake Tonetta, we suggest using fertilizer sparingly, if at all. If you must fertilize your lawn or garden, use a zero or low phosphorous fertilizer.

When shopping for fertilizer, remember that Nitrogen is the first number, Phosphorous the middle and Potassium (K), the third. For example, 4 - 0 - 10 is N - P - K.

Pest Management

Runoff containing lawn and garden pesticides also creates a problem for the Lake Tonetta environment. The Cornell Cooperative Extension promotes a comprehensive program called Integrated Pest Management. This is a nationwide process to monitor pest invasion and to control or treat the invasion with the least toxic method or with cultivation methods

Avoid Toxic Chemicals

Remember not to poison your Lake with toxic chemicals. Be extremely careful when handling gasoline, oil, paint, drain cleaners, bleach and other toxic materials in your home and yard.



Septic Repair Program

Putnam County is finalizing a "Septic Repair Program" using \$3.3 million of the East of Hudson Water Quality Improvement funds. The purpose of this fund is to design, implement and administer a household septic system inspection and rehabilitation program in certain sections of Putnam County. It is contemplated that Lake Tonetta will be designated as a "priority area" which would make all residents within 200 feet of the Lake eligible to participate.

Preliminary plans include that in exchange for the voluntary agreement by participating residents to allow a testing of their septic system and to properly maintain their systems (including a pump-out of the system at least every five years), the program would rehabilitate or replace septic systems at no cost to the home owner.

The Tonetta Lake Advisory Committee encourages residents to keep their eyes open for any materials which will come from Putnam County regarding this program.

Buffer Zone Plantings

85% of available phosphorous is bonded to small soil particles or sediment. A strip of forest or plants along the lakeshore functions as a FILTER by removing sediment and other suspended solids from surface runoff. In addition to removing up to 80% of the phosphorous -- ammonium, nitrates and other nutrients can be absorbed by buffer plants.

Ideal recommendations for a buffer zone range from 20 feet to 75 feet of managed and undisturbed forest. Obviously this may not be possible or practical in most areas of Tonetta's shore-line. However a buffer of any width will be of great help.

Lawn Care

- Cut lawns to 3 inches. This cuts down on weeds and watering, increases root growth and saves you time!
- Leave the clippings on the lawn. This will act as a mulch and save on watering.
- Leave an unmowed buffer strip at the edge of the Lake
- If you must fertilize, FALL is the best

benefit is that a shore line planting of at least three feet in height will also discourage geese from coming ashore.

There are many ornamental grasses, flowering shrubs and perennials such as native irises and joe pye weed that can make a buffer zone planting an attractive addition to your landscape.
