NOTICE IS HEREBY GIVEN that the Proposed Budget of the Croton Falls Fire District of the Towns of North Salem, Carmel and Southeast, State of New York, will be presented to the Board of Fire commissioners of the Croton Falls Fire District, for its consideration.

A PUBLIC HEARING will be held at 7:00 p.m. at the North Salem Substation, 301 Titicus Road, North Salem, New York 10560, in the Town of North Salem, State of New York on the 20th day of October, 2009.

Pursuant to Town Law S105, the board of Fire Commissioners must hold a public hearing on the budget, make the proposed budget available to the public prior to the public hearing, to allow the public to comment on the budget at the public meeting. This public hearing must be held to allow maximum public participation in the hearing.
